State Government of Andhra Pradesh and others etc. and later judgements. No Management/Institute/Trust or Society shall announce admissions directly under any circumstances. Any action contrary to this provision taken by the institute will make it liable to be de-recognized.

Further in the event of independence/contravention or non-compliance of the norms and standards as prescribed by the AICTE, the Council shall have further action to withdraw approval, and the liability arising out of such withdrawal of approval will be solely that of Management/Trust/Society and/or Institution.

The Council may inspect/visit the Institution any time it may deem fit to note the progress/compliance.

The attention of the management is drawn to the fact that the approval given now is only for one academic session, at the end of which an expert committee shall visit to assess if the norms and standards as stipulated by AICTE are fulfilled, and only then will the continuation or otherwise shall be intimated.

You are requested to check whether the progress made by these institutions for fulfillment of norms and standards of the Council and also the concerned Regional Office and AICTE, New Delhi is as desired.
